### Notes

- Subscriptions run for 12 months from the beginning of the month in which membership is taken out.
- Applications for Company Membership cannot, for legal reasons, be accepted from persons under the age of 18. Under 18's will be enrolled as Sandtoft Juniors - a "non-Company" support group for the Museum.
- Additional Family Company Membership can apply only to those additional adults (over 18) **resident at the same address**. Full membership rights and liabilities apply, but only one Company Journal per issue will be sent to the Company Members at that address; each Junior is entitled to a copy of the Company Journal
- Gift Aid: You do not have to opt in, but it will help us financially if you do tick the box. You can cancel the Gift Aid Declaration at any time by notifying Sandtoft Transport Centre Limited. If in the future your circumstances change and you no longer pay tax on your income and/or capital gains equal to the tax that we reclaim, you can cancel your declaration.
